

# MANUFACTURERS AND DISTRIBUTORS

It is unlawful for any person or entity to be involved in operating, carrying on, conducting or maintaining any form of manufacture, sale or distribution of any gambling device for use or play in Iowa without having first procured and maintained all required federal and state licenses.

A manufacturer's license is required of any entity that designs, assembles, fabricates, produces, constructs or otherwise prepares a product, or a component part of a product, or any implement of gambling useable in the lawful conduct of gambling games pursuant to Iowa Code Chapter 99F.

A distributor's license is required of any entity that sells, markets or otherwise distributes gambling devices or associated gambling equipment which is useable in the lawful conduct of gambling games to a licensee authorized to conduct gambling games pursuant to Iowa Code Chapter 99F.

A manufacturer or distributor of gambling games or implements of gambling shall annually apply for a license upon a form prescribed by the commission before the first day of April in each year and shall submit the appropriate license fee. An applicant shall provide the necessary information as the commission requires. The license fee for a distributor is one thousand dollars, and the licensee fee for a manufacturer is two hundred fifty dollars.
